

Food Vendor Registration Form

This registration form is for anyone selling food at the event, but not in the tenderloin contest. Spaces are 15ft x 15ft for \$50 if registered by May 15, 2019. After May 15th registration is \$75 and you may not be included in some of our advertising.

By registering and participating you agree to the following:

- Help promote the event. Share it on social media, tell your friends and customers about it, and/or take flyers to your other events. This helps create a buzz for the event which will also make the day better for you. We can send you flyers for display.
- Be open during the entire length of the event; 12pm-7pm.
- Set up times will be staggered to aid in the process. You will be contacted closer to the event with your time. It is extremely important that you arrive at your designated time. If you arrive late and the area is blocked off we may not be able to get you into the event.
- All items must be removed by 9pm.
- General Liability Insurance coverage must be provided for a minimum of \$1,000,000 naming "Main Street Greensburg" and "City of Greensburg" as additional insured.
- Vendors will comply with all State and Decatur County health regulations. Participants/vendors must obtain a Temporary
 Food Service Permit from the Decatur County Health Department by filling out a "Temporary Food Service Application Form."

- Photos of the sale may be taken and used at the discretion of Main Street Greensburg.
- You are liable for all items that are sold, for the personal protection of monies and belongings, and for any costs for damages to customers or the grounds.
- The sale of fireworks, firearms, knives, alcohol, tobacco, regulated substances, recalled, unsafe, and other offensive novelty items are not permitted.

• WAIVER, RELEASE AND INDEMNITY AGREEMENT

In consideration of acceptance of my entry, I hereby release, discharge, and agree to hold harmless Main Street Greensburg, Decatur County, the City of Greensburg, and any sponsors, officials or organizers of this event and each of them together with their successors, assigns, officers, agents, and employees from any and all liability for injuries to property or person suffered by me as a result of my participation in this event. By execution of this waiver, I assume all risks associated with my participation in this event including, but not limited to the effects of weather, traffic, beverage handling, and all risks associated with vending to the public whether or not such risks are specifically known or appreciated by me. I specifically agree that is it not the duty of any of the parties listed above to check, monitor, or evaluate the appropriateness of my participation in this event at any time. I agree to indemnify any of the parties listed above for damages cause by me to any such party or parties and any third parties, by virtue of my participation in this event.
